World's largest aquarium at SeaWorld Abu Dhabi

Abu Dhabi, Aug 13: Miral, Abu Dhabi's leading curator of magnetic experiences, in partnership with SeaWorld Parks & Entertainment, announced recently a significant progress on the construction of SeaWorld Abu Dhabi, the next

generation of marine life theme parks and Yas Island's latest mega-development. The marine-life park, which is set to feature the world's largest and most expansive marine aquarium and the new Yas SeaWorld Research and Rescue

A main focal view of the aquarium will present visitors with the “Endless Vista”, an impressive 20m tall vertical window across multiple levels revealing stunning aquatic scenes.

No test for fully vaccinated: Tourism Ministry

New Delhi, Aug 13: The Union Ministry of Tourism has urged all state governments to drop the provision of mandatory RT-PCR tests for visitors who have received both doses of COVID-19 vaccine.

In a letter to all states, the ministry said the matter was discussed at a virtual meeting with all state and union territory Tourism department principal secretaries and

the Federation of Associations in Indian Tourism and Hospitality (FAITH) under the chairpersonship of the Union tourism secretary on August 5.

Currently, only some states like Maharashtra and Sikkim allow entry to fully vaccinated travellers without negative RT-PCR reports.

States such as West Bengal (for travellers from Mumbai, Pune and Chennai), Karnataka, Goa



and Chhattisgarh still ask for negative RT-PCR reports, irrespective of double vaccination status.

The ministry said that the removal of the provision would help build confidence among travel-

ers and boost tourism. Sources indicate that the ministry took this step after various tourism stakeholders complained that such provisions seriously affected their businesses.
